It is for General information of all concern that the public auction will be held at 41<sup>ST</sup> Bn SSB Ranidanga, P.O Sushrutanagar, Distt. Darjeeling, West Bengal for disposal of unserviceable stores, on the date & time mentioned below:-

#### TERMS AND CONDITIONS:-


1. Bidders can take part in bidding after depositing Rs. 10,000/- (Rupees Ten Thousand) only as security money before one hour of commencement of auction. Security money of successful bidders will be adjusted with their bid amount. Only those bidders who deposit the security money will be allowed to attend the auction.  
Bidders are requested to reach venue will in advance to avoid last minutes risk.
2. The security money of the bidders whose bids will be rejected shall be refunded as soon as bidding is over.
3. The auctioned store will have to be lifted/ removed within two days of the date of auction. Successful bidders will have to make his own arrangement for security of stores. Department will have no responsibility for the same.
4. Bidder will carry their PAN Card and VAT registration certificate at the venue of Auction.
5. On the fall of the hammer the successful bidder (Highest bidder) will deposit final payment of the auction value of the store in presence of the board. The stores will be sold to highest bidder on receipt of bid amount in full and production of tax clearance certificate as applicable.
6. In case of failure to make balance payment of bid value by the bidder within stipulated period the sale of lot will be treated as cancelled and security money will stand forfeited.
7. The store so auctioned will be removed completely at the bidder's expense/risk from the site and if the buyer fails to remove the auctioned stores within the stipulated period, the auctioneer will not be responsible for any lose/damage for the same. Rent of the space occupied by the store will be charged as per rules.
8. The stores may be inspected before one hours of commencement of auction after obtaining approval from office of the Commandant 41<sup>ST</sup> Bn SSB Ranidanga.
9. The stores will be sold on "AS IS WHERE IS BASIS" and the release order will be issued in the name of the successful bidder only.
10. The bidder should abide by the security instruction issued by the officers conducting auction at the venue of auction.
11. Pooling and canvassing/Trading during the auctions/inside auction premises will not be allowed. If any grouping/pooling from any bidder (s) is noticed, the concerned bidder (s) will not be allowed to participate in the auction.
