Notification

G.S.R. _____(E) - .In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the Special Service Bureau Veterinary posts Group 'A' Recruitment Rules, 2003 except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the Group 'A' posts {Chief Veterinary Officer (SG), Chief Veterinary Officer, Senior Veterinary Officer and Assistant Surgeon (Veterinary)} in the Sashastra Seema Bal, Non-Combatised (Veterinary) Service under the Ministry of Home Affairs, namely:-

1. **Short title and commencement.**- (1) These rules may be called the Sashastra Seema Bal Veterinary Officers (Non-Combatised) Group 'A' posts Recruitment Rules, 2016.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. **Applications.**- These rules shall apply to the posts specified in column (1) of the Schedule annexed to these rules.

3. **Number of post, classification and pay band and grade pay or pay scale .-** The number of posts, their classifications, the pay band and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the aforesaid Schedule.

4. **Method of recruitment, age limit, qualification, etc.**- The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.

5. **Disqualification.** - No person,-

(a) who, has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person:

shall be eligible for appointment to the said posts:

Provided that the Central Government may if satisfied that such marriage is permissible under the personal law applicable to such person and to other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of these rules.

6. **Superannuation.** - The personnel appointed under these rules shall retire from service on the afternoon of the last day of the month in which he attains the age of sixty years.

Provided that a person whose date of birth is the first day of a month shall retire from service on the afternoon of the last day of the preceding month on attaining the age of sixty years.

7. **Power to relax.** - Where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing, and in consultation with Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.

8. **Liability of service.**- Any person appointed to the said posts under these rules shall be liable to serve anywhere in India or abroad.

9. **Saving.** - Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, Ex-servicemen and other special categories of persons, in accordance with the orders issued by the Central Government from time to time in this regard.
