DETAILS OF POSTS TO BE FILLED UP AT NEPA ON DEPUTATION**(1) Dy. Assistant Director (Outdoor) – (1 post)**

Officers under the Central / State Police Organisation :

- (i) Holding analogous post on regular basis in the grade or with five year regular service with GP of Rs. 4200/-
- ii) Preferably having experience in teaching outdoor subjects like Drill & Weapon, Tactics, Map Reading, CIJW, Commando course, PT, Horse Riding etc. Must have experience in handling, conducting or organizing training schedules.
- iii) For Armed personnel – Transfer on deputation / re-employment (for ex-servicemen) – Armed Forces Personnel up to the level of Junior Commissioned Officers who are due to retire or who are to be transferred to reserve within a period of one year shall be eligible to be appointed on deputation and thereafter on selection they may be continued on re-employment terms, provided that in case such eligible officers have retired or have been transferred to reserve before the actual selection to the post is made, their appointment will be on re-employment basis.

Preference will be given to officer, who has worked in training Institute as instructor.

(2) Sub-Inspector (GD) – (1 post)

For Transfer on deputation –

Personnel holding analogous post on regular basis in the grade or ASI with three years of regular service or Head constable (GD) with eight years of regular service. Personnel having working experience as Instructor in Training Institutions will be preferred.

(3) Head Constable (GD) – (3 posts)

For Transfer on deputation –

Personnel holding analogous post on regular basis in the grade or Constable (GD) with five years regular service, Personnel who have working experience as Instructor in Training Institution will be preferred.

(4) Head Constable (MT) – (1 post)

For Transfer on deputation –

Personnel holding analogous post on regular basis in the grade or Constable (MT) with five years regular service, having experience of driving different types of vehicles. Personnel who have working experience as Instructor in Training Institution will be preferred.

(5) **Head Constable (MT Mechanic) - (1 post)**

For Transfer on deputation –

Personnel holding analogous post on regular basis (Constable (MT Mechanic) with three years regular service or Constable (MT Mechanic) with five years regular service having knowledge of elementary mechanism, relating to different types of vehicles etc.

Pay & Allowances –

The selected personnel will have the option to draw their present Basic Pay in the scale of pay of their parent departments and GP plus other allowances, as admissible during the period of deputation. In addition 30% training allowance and 12.5 SDA on their BP will also be admissible. Ration Money and Washing Allowance is allowed as per rates applicable in their parent department.

Other facilities –

1. **Accommodation** – Rent free accommodation
2. **Medical** - The Academy has a 10 bedded hospital within the campus with a Medical Officer and attending staff. Medical reimbursement is also admissible for treatment outside the Academy
3. **Education** - There is a Kendriya Vidyalaya in the Academy Campus upto Class XII for the children. School bus is provided to all the children going to Colleges / University etc. in Shillong.
4. **Welfare** – There are Co-operative Store, Wet Canteen, Dairy Farm, Shopping Complex, Theatre, Swimming pool available to meet the basic requirements of the residents of NEPA Campus.

Note : *It is requested that the nominations with full Bio-Data and Service and posting particulars, Course attended / Cadre details, Confidential Reports of last 5 years of those personnel who could be spared in the event of their selection, may kindly be sent to this Academy. While forwarding the applications, it may kindly be verified and certified that the particulars furnished by the officers are correct and that no disciplinary cases are pending or contemplated against the nominee.*
