3. The highest bid offered will be accepted by the board of officers. The amount of accepted highest bid will have to be deposited in full and in cash before lifting of the store.
4. Auctioned store will have to be lifted from the aforesaid premises within 24 hours failing which flat rate (addition charges) shall be charged from the owner of stores and board will not be responsible for any loss/damage.
5. No any transport or assistance for lifting of auctioned stores will be provides by this office.
6. Other terms and conditions will be announced by the board of offices on the auction spot before commencement of the public auction.
7. No more than one person will be allowed to enter in the campus with each bidder.
