

INTERNATIONAL MEMORANDUM OF UNDERSTANDING

This non-binding Memorandum of Understanding ("MoU") is executed on 9<sup>th</sup> June, 2017 by and between:-

**SASHASTRA SEEMA BAL** having its headquarters at **East Block V, Sector -1, R.K. Puram, New Delhi-110066** (hereinafter referred to as "**SSB**" which expression unless repugnant to the context shall mean and include its representatives, affiliates and assigns).

**AND**

**THE AJG INTERNATIONAL** a company registered under the Companies Act, 1956 having its corporate office at **BMS, 10, Plaza Cinema Building, Connaught Place, New Delhi** (hereinafter referred to as "**THE AJG INTERNATIONAL**" which expression unless repugnant to the context shall mean and include its representatives, affiliates and assigns).

**WHEREAS:**

- A. **THE AJG INTERNATIONAL** is engaged in the business of providing hotel and accommodation services across 51 cities in India, through its network of 51 hotels ('**Accommodation Services**').
- B. **THE AJG INTERNATIONAL** has approached **SSB** with a proposal to offer its Accommodation Services to the employees of all ranks and guests (including their immediate family members) of **SSB** ('**Guests**').
- C. In this regard **THE AJG INTERNATIONAL** and **SSB** wish to execute this non-binding MoU on the terms and conditions stated herein below.

**1. PARTIES**

- 1.1 This document constitutes the entire understanding between **THE AJG INTERNATIONAL** and **SSB** with respect to the Accommodation Service provided by **THE AJG INTERNATIONAL** to the **Guests**.

**2. ACCOMMODATION SERVICES**

- 2.1 **THE AJG INTERNATIONAL** agrees and understands:
  - 2.1.1 That, bookings for Accommodation Services will be made and used by the **Guests** and will be handled by **THE AJG INTERNATIONAL**. It is hereby clarified that **SSB** shall not be liable for any claims and / or liabilities which may arise with respect to such bookings. Further, **THE AJG INTERNATIONAL** will not be entitled to any services fee from **SSB** in this regard.
  - 2.1.2 That, there is no obligation on **SSB** to provide any bare minimum booking / business to **THE AJG INTERNATIONAL**.
  - 2.1.3 That, **SSB** may inform their offices across India, through notification or otherwise of the execution of this MoU and may promote the services provided by **THE AJG INTERNATIONAL** from \_\_\_\_\_ time \_\_\_\_\_ to \_\_\_\_\_ time.

- 1.4 That THE AJG INTERNATIONAL shall not offer lower rates than SSB to any other party and if they do so, similar rates should be made applicable to SSB.
- 1.5 That THE AJG INTERNATIONAL will provide the following facility to the SSB occupant and their guests :
- Free Wi-Fi in the hotel .
  - Free stay of spouse with meals .
  - Free utilization of other hotel facilities e.g. Gym., Swimming Pool. etc.
  - Any facility of early check-in or later check-out facility on payment basis .

### 3. TERMINATION

- 3.1.1 The terms of the MoU shall commence from the date mentioned above and shall continue for a period of one (1) year and shall automatically renew unless terminated otherwise by either party by serving one (1) month notice of termination to the other party .
