**AUCTION NOTICE**

It is for general information to all concerned that a public auction will be held as per details (i.e. date, time, place and nature of stores) mentioned below for disposal of un-serviceable (U/S) stores held on the charge of 25<sup>th</sup> Bn. SSB, Ghitorni, New Delhi.

All interested bidders/parties are invited to attend the auction on the date and time mentioned above. The terms and condition of the auction are as under :-

- i) The Vendors should be registered with the Government Agency as per e-waste Management and Handling Rules, 2011 published by Ministry of Environment and Forest (MOEF) Notification dated 12<sup>th</sup> May, 2011
- ii) The bidders attending auction will have to deposit a sum of Rs. 25,000/- (Rupees Twenty five thousand) only as security money which will be refunded to unsuccessful bidders after auction is over. Only those bidders depositing security money will be allowed to take part in the auction.
- iii) The Commandant, 25<sup>th</sup> Bn. SSB, Ghitorni, New Delhi reserves the right to reject/accept the auction without assigning any reason. If any dispute arises, the decision of the Board will be the final.
- iv) Immediately, on the falls of the hammer the successful bidder (highest Bidder) will deposit the amount of bid at the spot in full and cash only.
- v) Auction stores should be shifted on the same day and no transportation will be provided by this office for shifting of auction stores.  
The full amount of the accepted bid will have to be deposited at the time of fall of hammer by the successful bidder.
- vi) Inspection of U/S stores will be allowed before start the auction. The U/S stores will be disposed off on the assumption that the bidder have inspected the stores and have gone through the terms and condition of auction. No complaint of any kind will be entertained later on.
- vii) The U/S stores will be auctioned lot wise.
- viii) Every bidder should furnished valid income tax, sale tax clearance certificate, clear up to assessment year 2016-17. In absence of income tax/sale tax clearance certificate security money will not be deposited and bidder shall not allow participating in the auction.
