

### AUCTION NOTICE

It is for general information to all concerned that a public Auction will be held on 4<sup>th</sup> /8/2016 at 1000 hrs at Transit Camp 24<sup>th</sup> Bn SSB, Nandini Nagar, Nandini Town SEjp, Dist. #### Terms and Conditions

1. Bidders will be allowed to participate in Auction on production of tax registration / Vat registration of their firm. The firm should be in their own name (not through representative) they will also have to prove their own identity and produce PAN card. They will bring photo copies of all these documents with them and deposit these copies with security deposit.
2. Bidders can take part in bidding after depositing Rs.12,000/- (Rupees twelve thousand) only as security money up to one hour before commencement of auction. Security money of successful bidders will be adjusted with their bid amounts. Only those bidders who will deposit their security money will be allowed to attend the auction.
3. The security money of the bidders whose bids will be rejected shall be refunded immediately after bidding is over.
4. The auctioned stores will have to be lifted / removed within three days of the date of auction. For the security and safety of the stores, successful bidders will have to make their own arrangements and department will have no liability for the same.
5. On the fall of the hammer the successful bidders (Highest bidder) will deposit 100% payment of the auction price / bid with the stock holders in presence of the presiding officer of the board within half an hour. If successful bidder fails to deposit 100% of his bid amount immediately his security deposit will be forfeited and auction will be continued further. The stores be sold to highest bidder on payment of bid amount in full and production of tax clearance certificate as applicable.
6. In case of failure to make balance payment of bid value by the bidder within stipulated period the sale of lot will be treated as cancelled and security money will stand forfeited.
7. The Store so auctioned will be removed completely at the bidder's expense / risk. This office will not be responsible for any loss / damages for same rent of the space occupied by the store will be charged as per Rates.
8. The stores will be sold on "AS IS WHERE IS BASIS" and the release order will be issued in the name of the successful bidder only.
9. The vendor should be registered with Govt. agency as per E waste management and handling rules 2011 published by Ministry of environment and Forests notification dt 12/05/2011.
10. The bidder should abide by the security instruction issued by the officers conducting auction at the venue of auction.
11. Pooling and canvassing / Trading during the auctions inside auction premises will not be allowed. If any grouping /pooling from any bidders is noticed the concerned bidders will not be allowed to participate in the auction.
