

S.O. 2777(E).—In exercise of the powers conferred by section 5 of the Customs Act, 1962 (52 of 1962), the Central Government hereby entrusts to the officers and subordinate officers of the Sashastra Seema Bal constituted under section 4 of the Sashastra Seema Bal Act, 2007 (53 of 2007) and mentioned in column (2) of the Table below, the functions of an officer of customs specified in the corresponding entry in column (3) of the said Table and directs that each such officer and subordinate officer shall exercise the functions of an officer of customs within the local limits of the areas specified in the Schedule hereto annexed, namely:—
