

## AUCTION NOTICE

All interested bidder/parties are invited to attend the auction on the date and time mentioned above. The terms and condition of auction are as under.

### TERMS AND CONDITION:-

01. The bidders will have to deposit Rs. 10,000/- (Rupees Ten thousand) only as security money before start of auction, which will be refunded to them on the completion of the auction. Only those bidders depositing money will be allowed to participate in the auction.
02. The Commandant, 49 BN SSB Ranchi (Jharkhand) reserve the right to reject/ accept the auction without assigning any reason. If any dispute arises, the decision of the board will be the final.
03. The unserviceable stores will be auctioned lot wise.
04. The highest bid offered will be accepted by the board of Officers. The amount of accepted highest bid will have to deposit in full by cash before lifting of the stores. In case the highest bidders fail to deposit auctioned value of stores in full, the sale of lot will be treated as cancelled and earnest money paid by him will be forfeited. Only cash payment will be accepted.
05. Every bidder must produce photocopies of last income and sale tax clearance on the spot at the time of auction.
06. The stores auctioned will be removed completely by the buyer from the site within 48 hrs after the auction. If the bidder fail to remove the auctioned stores this office will not be responsible for the loss/damage of sold property. In case of Tax due under provision of local administrative norms will be abide and bear by the buyer.
07. Every bidder must produce photo ID proof on the spot at the time of auction.
08. The buyer will deposit the sale tax receipt copy before lifting the stores and the release order will be issued in the name of actual highest bidder only.
09. The bidder will maintain the security measures as asked for by this department at the time of auction. Any grouping and advertisement during the auction / in auction premises will not be allowed and in such cases, the bidder ship will be forfeited.
10. The bidders should be registered with Govt. agency as per E-Waste Management and handling rules 2011 published by Ministry of Environment and Forests notification dated 12<sup>th</sup> May 2011.
11. No transportation or assistance for lifting of auctioned store will be provided by this office.
12. Not more than one person will be allowed to enter the campus with the person going to take part in the auction.
13. The board of officers before commencement of auction will announce other terms and conditions.
