BPR&D vide letter dated 08/08/2016 (copy enclosed) has invited nomination of officers for 57<sup>th</sup> National Defence College Course at National Defence College, New Delhi commencing from 9<sup>th</sup> January, 2017 to 30<sup>th</sup> November, 2017 (.) Eligibility criteria for the course are as under:

1. IPS officers having not less than 14 years of completed services
2. CAPF officers holding the equivalent rank of Director/Senior Deputy Secretary of a Central Ministry or state department and who are likely to reach policy making level of Joint Secretary or equivalent having not less than 16 years of completed services
3. Below 50 years of age as on 01/01/2017 with sound physical and mental health
4. Excellent record of past performance
5. Clearance from vigilance and disciplinary angle
6. Officers should not have undergone a training programme of 12 weeks of more duration in India during a period of 5 years preceding the date of commencement of this course. Further, the officer should not have undergone a programme of training abroad of more than 2 weeks in preceding 2 years, more than 1 month in the preceding 3 years or more than 6 months in preceding 5 years.

It is requested to forward willingness of eligible officers in the rank of Commandant and above for the said course alongwith Annexure – A to G by 22/08/2016 rpt 22<sup>nd</sup> August, 2016 for taking further necessary action at this end (.) Willingness received without annexure will not be entertained (.)

**Subject :** Inviting nomination for 57<sup>th</sup> National Defence College Course at National Defence College New Delhi commencing from 09<sup>th</sup> January, 2017 to 30<sup>th</sup> November, 2017- regarding

Sir,

Nomination of Police officers for 57<sup>th</sup> NDC Course at National Defence College, New Delhi commencing from 9<sup>th</sup> January 2017 are invited as per eligibility criteria and conditions mentioned below:

- i) IPS officers having not less than 14 years of completed services;
- ii) CAPF/CPO/State Police officers holding the equivalent rank of Director/Senior Deputy Secretary of a Central Ministry or state department and who are likely to reach policy making level of Joint Secretary or equivalent having not less than 16 year of completed services;
- iii) **Below 50 years** of age as on **01.01.2017**, with sound physical and mental health;
- iv) Excellent record of past performance;
- v) Clearance from **Vigilance** and **Disciplinary** angle;
- vi) Officers should not have undergone a training programme of **12 weeks of more duration in India during a period of 5 years** preceding the date of commencement of this course. Further, the officer should not have undergone a programme of **training abroad of more than 2 weeks in preceding 2 years, more than 1 month in the preceding 3 years or more than 6 months in preceding 5 years.**

2. As per the decision taken by the MHA, Govt. of India, BPR&D will bear the cost of tuition fee ONLY amounting to Rs.2,10,000 in respect of nominated officers.

3. The sponsoring authority, namely, the organization where the official is currently posted, will meet the cost of:

- (i) **Pay and Allowances**
- (ii) Internal and Foreign Tours
- (iii) Travel from place of posting to NDC, New Delhi and back
- (iv) Any other expenses/charges, during the currency of the course.

4. The nominated officer shall give an undertaking:
- i) That his services can be utilized as **Resource Person** in the area of his specialization by the Central/State Government Organizations as and when required;
  - ii) That he will provide his **expertise** to the Central/State Government Organizations as and when required;
  - iii) That he would **complete** the proposed training programme within the **stipulated period** and submit a copy of his **thesis/research work** to MHA/BPR&D so that it could be circulated to States/CPOs/CAPFs
  - iv) The officers selected for NDC course will be required to execute a '**Bond**' prior to his/her joining the NDC course and submit the same to his/her Cadre Controlling Authority stating that he/she would serve the Government for a period of five years and he/she would be willing to work in Ministry of Home Affairs, Ministry of external Affairs, Ministry of Defence, NSCS and other security-related organization on completion of course, or to repay the total expenses incurred on the NDC course in the event of his/her resignation, voluntary retirement or quitting the NDC Course without completing it.

5. It is requested that the above instructions may please brought to the notice of all concerned. The concurrence of the States Government wherever necessary; should also be obtained and intimated to this Bureau for officers who are on deputation with Central Govt. departments.

5. It is brought to your notice that as per MHA circular received by this Bureau, incomplete/piecemeal information received for nominated officer will not be considered.
