All interested bidder/parties are invited to attend the auction on the date and time mentioned above. The term and condition of auction are as under:-

TERMS AND CONDITION

- Bidders will be allowed to participate in Auction on production of tax registration /VAT registration of their firm. The firm should be in their own Name . They will also have to produce their own identity and PAN card .They will bring photo copies of all these documents with them and deposit the photocopies alongwith security deposit.
- Bidders can take part in bidding after depositing Rs. 25,000/- (Rupees twenty five thousand) as security money upto one hour before commencement of auction. Security money of successful bidders will be adjusted with their bid amounts. Only those bidders who deposit the security money will be allowed to attend the auction. Bidders are requested to reach the venue well in advance to avoid last minutes risk.
- The security money of the bidders whose bids will be rejected shall be refunded immediately after bidding is over.
- The auctioned stores will have to be lifted / removed within three days from the date of auction for the security and safety of the stores, successful bidders will have to make his own arrangements and department will not responsible for any lapse.
- On the fall of the hammer the successful bidder (Highest bidder) will be deposited 50% payment of the auction price/bid with the stock holders in presence of the Presiding Officer of the board within half an hour. If successful bid.
- Bidder fails to deposit 50% of his bid amount immediately his security deposit will be forfeited and auction will be continued further. The stores will be sold to highest bidder on payment of bid amount in full and produce of tax clearance certificate.


