It is for general information of all concerned that the following categories of condemned Government stores of 43RD Bn SSB, Pattan (J&K) will be disposed off by Public Auction of worth Rs.17,01,696/- (Rupees Seventeen Lakhs One Thousand Six Hundred Ninety Six) only to be held on 07/11/2016 at 1100 Hrs, located at 43RD Bn SSB, Babateng, near SDPO Complex, Baramulla (J&K).

TERMS AND CONDITIONS OF AUCTION WILL BE AS UNDER:



1. The stores will be auctioned on "As is where basis is".
2. The bidder will have to deposit Rs. 25000/- (Rupees Twenty Five Thousand) only as security money before start of auction and this money will be refunded to them on completion of the auction process. Only those bidders who will deposit advance security money will be allowed to enter in auction area and take part in the auction.
3. Immediately on the fall of the hammer the successful bidder (highest bidders) will deposit the full amount in case of bidding at the post.
4. The Commandant/P.O. of auction board has reserve the right to reject/ accept auction without assigning any reason and the decision of the board will be final and binding in all matters related to auction.
5. Auctioned stores should be shifted on the same day and no transport will be provide by the unit for shifting of auctioned stores.
6. Inspection of unserviceable stores will be allowed before starts of auction to bidders who have deposited advance security money. The unserviceable stores will be disposed off on the auction, no complaint to any kind will be entertained at later stage.
7. In case, the numbers of bidders fall below five it may be postponed.
8. Security money will be collected on 07/11/2016 from 0900 hours to 1100 hours.
9. The highest bid offered will be accepted by the board of officer, the amount of accepted higher bid will have to deposit in full by cash before lifting the store. In case highest bidder fails to deposit auctioned value of stores in full, the sale lot will be treated as cancelled and EXMD paid by him will be forfeited. Only cash payment will be accepted.
10. The store shall remain in every respect of the risk of the buyer from the date of acceptance of his offer by the auction board. Commandant 43RD Bn SSB, Pattan and the Government /Department shall not be responsible for the safe custody or preservation thereof from the date of auction till the date of final removal.
11. Every bidder should furnish latest/current income tax and sale tax clearance certificate and photo state copy there off from his permanent account number were already allotted at the time of signing the bid sheet. The certificate should be the name and address given by the bidders. In absence of current income tax/sale tax clearance & security money, bidder will not be allowed to participate in the auction.
12. The goods will be sold to the highest bidder. The buyer will have to produce up to date sale tax/income tax clearance certificate from the competent authority of government of Srinagar GOI, together with a photo copy of the same to this office for issuing removal orders of the auction items from this end.
13. In all cases tax due under any provincial local law shall be payable by the purchaser of store.
14. The bidder will adhere to the security instruction of the unit.
15. The release order challan will be issued in the name of actual purchaser only.
