It is for general information to all concerned that a public auction will be held on 21/10/16 at 10:00 at 28th BN SSB Araria for disposal of following categories condemned stores belonging to the 28th Bn SSB Araria. The terms and condition for the Auction will be as under:-

01. Bidders will be allowed to participate in auction on production of Tax registration/VAT registration of their firm. The firm should be in their own name (not through representative). They will also have to prove their own identity and PAN card. They will bring photo copies of all these documents with them and deposit these copies with security deposit.
02. Bidders can take part in bidding after depositing Rs. 30,000/- (Thirty thousand) only as Security money up to one hour before commencement of auction. Security money of successful bidders will be adjusted with their bid amount. Only those bidders who deposit the security money will be allowed to attend the auction. The security money of the bidders whose bids will be rejected shall be refunded immediately after bidding is over.
03. The auction stores will have to be lifted /removed from the site immediately after the auction at the buyer's expense. If the bidder fails to remove the auctioned stores on the same day after depositing sale tax with sale tax office, this office will not be responsible for any loss/damage of the same.
04. On the fall of the hammer the successful bidder (Highest bidder) will deposit 100% payment of the auction price/bid with the stock holders in presence of the Presiding Officer of the board within half an hour. If successful bidder fails to deposit 100% of his bid amount immediately his security deposit will be forfeited and auction will be continued further. The stores will be sold to highest bidder on payment of bid amount in full and production of tax clearance certificate as applicable.
05. In case failure to make balance payment of bid value by the bidder within stipulated period the sale of lot will be treated as cancelled and security money will stand forfeited.
06. The store will be sold on "AS IS WHERE IS BASIS" and the release order will be issued in the name of the successful bidder only.
07. The bidder should abide by the security measures issued by the officers conducting auction at the venue of auction.
08. Pooling and canvassing/Trading during the auction /inside auction premises will not be allowed. If any grouping/pooling from any bidder (s) is noticed, the concerned bidder (s) will not be allowed to participate in the auction.
09. Not more than one person will be allowed to enter the campus with person going to take part with auction.
10. Every bidder must produce photocopies of last Income and sale tax clearance on the spot at the time of auction.
11. In case number of bidders fall below five, the auction may be postponed.
12. In case of any bidder fails to obey terms & conditions as per notice, bidder/bidders will be disqualified and security deposit will also be forfeited.
13. The payment will be accepted by cash or DD of Nationalized bank only.
14. The commandant 28th BN SSB Araria or the Officer conducting the auction on his behalf reserves the right to accept or reject any bid without assigning any reason and in case of dispute, the decision of the board of officers shall be final.


