Sub: Payment of Nursing Allowance to the nursing personnel of CPFs at the rate applicable to the nursing personnel of Central Government hospitals

The undersigned is directed to state that in partial modification to this Ministry's order of even no dated 28.7.2009 on the above subject, para 2 of the order will be read as under:

"All Nursing personnel are eligible for Nursing Allowance as per the Ministry of Health & Family Welfare's OM No.Z.28015/86/97-N dated 28.7.1998. However, to practice nursing, it is essential to possess Registration Certificate like RN, RM, RANM etc from the State Nursing Council (SNC) and also the nursing programme has to be recognized by the Indian Nursing Council (INC). Therefore, personnel possess the INC approved qualification and RNM or Registration Certificate from the State Nursing Council, are eligible to practice as Nursing personnel and therefore eligible for Nursing Allowance"

2. All other provisions of the aforementioned order remain as they are.
3. This issues with the approval of the Ministry of Finance, Department of Expenditure vide ID No. 21782/JS(Per)/2012[F.No.19050/1/1998-E.IV(Vol.II)] dated 4.1.2013 and concurrence of Integrated Finance Division of this Ministry vide Dy.No.42567/Fin.II/13 dated 29.1.2013.
