TERMS AND CONDITIONS OF THE AUCTION ARE AS UNDER :-

- 1 The bidders are requested to deposit Rs. 20,000/- (Rupees twenty thousand) only as security money /earnest money before one hours of start of auction and this amount will be returned to them on completion of the auction. The amount will be adjusted later on against the final bid amount to the highest bidder and the earnest money of the unsuccessful bidders will be returned immediately after bidding is over.
