AUCTION NOTICE.

A public auction of the following condemned stores of the office of the Commandant, 38th Bn. SSB, Tawang (A.P) will be held on **06/05/2016** at **1000** hrs. in the complex of 38th Bn. SSB, Tawang (A.P).

- (a) Miscellaneous stores.
- (b) M.T stores Tyres, Tubes, Flaps, Battery and Hood Canvas.
- (c) Spare Parts of Vehicles.
- (d) W. T Stores.

TERMS & CONDITIONS FOR CONDUCTING PUBLIC AUCTION ARE AS UNDER:-

01. The bidders have to deposit **Rs. 10, 000/- (Rupees Ten thousand)** only as security money before start of the auction and this will be refunded to unsuccessful bidders after completion of auction process only those bidders who will deposit advance security money will be allowed to take part in the auction.
02. Immediately, on the fall of the hammer the successful bidders (Highest bidders) will deposit the full amount in cash of bidding at the post.
03. Auctioned stores should be shifted of the stores on the same day and no transport will be provided by the unit for shifting of auctioned stores.
04. Inspection of U/S stores will be allowed before start of auction. The public auction will be held on **“As is where is” and “As is what is” and “whatever there is” basis” and “without recourse basis”**. The condemned stores will be disposed off on the auction. No complaint to any kind will be entertained at later stage.
05. In case, the number of bidders fall below five auction may be postponed.
06. Security money will be collected on **06/05/2016** from **0900** hours to **1000** hours.
07. 100% of sale value will be collected in cash on spot after completion of sale proceeding.
08. In the event of failure of complete payment within stipulated date and time the security money deposited by the bidder concerned will be forfeited and the goods will be resold on any date as will be deemed fit by the authority without any notice to the defaulter bidder concerned.
09. The stores shall be remain in every respect of the risk of the buyer from the date of acceptance of his offer by the Commandant, 38th Bn. SSB, Tawang (A.P) and the Government/Department shall not be responsible for the safe custody or preservation there off from the date of auction till the date of final removal.

10. every bidder should furnish current income tax/sale tax/clearance certificate and photo state copy there off from his income tax/sale tax and officer indicating that the bidder is assesses of his ward and his permanent account number were already allotted at the time of singing the bid sheet. The certificate should be in the name and address given by the successful bidder. In absence of current income tax/sale tax, clearance & security money being deposited by the bidder will not be allowed t participate in the auction.
11. The goods will be sold to the highest bidder. The buyer will have to produce up to income tax/sale tax clearance certificate from the competent authority of Government of Arunachal Pradesh along with photo copy of the same to this office for issuing removal orders of the auctioned items from this end.
12. In all cases tax due under any provincial/local law shall be payable by the purchaser of stores.
13. The bidder will adhere to the security instruction of the unit.
14. The release order Challan will be issued in the name of actual purchaser only.
15. Grouping and advertisement during the auction in question at the auction venue will not be allowed, if found any grouping from the part of bidder, the concerned bidder will not be allowed to participate in auction and his bidder lip will cancelled. The point should be adhered strictly.
16. Any dispute regarding matter would be under of courts in Tawang (A.P) only.
17. The Commandant, 38th Bn. SSB, Tawang (A.P) reserve the right to reject/accept the auction without assigning any reason. If any disputes arise, the decision of the board will be final and binding.
18. **The vendor should be registered with Govt. Agency as per E-Waste management and handling rules 2011 published by Ministry of environment and forests notification dated 12th May 2011.**


