AUCTION NOTICE

It is for general information to all concerned that the public auction will be held as per details (ie. date, time, and nature of store) given below for disposal of U/S store held on charge by 18th Bn SSB Dumka (Jharkhand).

All interested bidder/parties are invited to attend the auction on the date and time mentioned above. The term and condition of auction are as under:-

TERMS AND CONDITION

1. Bidders will be allowed to participate in Auction on production of tax registration/GST registration of their firm. The firm should be in their own Name. They will also have to produce their own identity and PAN card. They will bring photo copies of all these documents with them and deposit the photocopies along with security deposit.
2. Bidders can take part in bidding after depositing Rs. 25,000/- (Rupees twenty five thousand) as security money upto one hour before commencement of auction. Security money of successful bidders will be adjusted with their bid amounts. Only those bidders who deposit the security money will be allowed to attend the auction. Bidders are requested to reach the venue well in advance to avoid last minutes risk.
3. The security money of the bidders whose bids will be rejected shall be refunded immediately after bidding is over.
4. The auctioned stores will have to be lifted / removed within three days from the date of auction for the security and safety of the stores, successful bidders will have to make his own arrangements and department will not responsible for any lapse.
5. On the fall of the hammer the successful bidder (Highest bidder) will deposit 20% payment of the auction price/bid with the stock holders in presence of the Presiding Officer of the board within half an hour.
6. If successful bidder fails to deposit 50% of his bid amount immediately, his security deposit will be forfeited and auction will be continued further. The stores will be sold to highest bidder on payment of bid amount in full and produce of tax clearance certificate.
7. In case of failure to make balance payment of bid value by the bidder within stipulated period the sale of lot will be treated as cancelled and security money will stand forfeited.
8. The store so auctioned will be removed completely at the bidders own expense/risk. The auctioneer will not be responsible for any loss/damages for the same. Rent of the space occupied by the store will be charged as per rules.
9. The U/S stores will be auctioned lot wise
10. The stores will be sold on "AS IS WHERE IS BASIS" and the release order will be issued in the name of the successful bidder only.
11. The bidder should abide by the security issued by the officers conducting auction at the venue of auction.
12. Pooling and Canvassing / trading during the auctions / inside auction premises will not be allowed. If any grouping / pooling from any bidder (s) is noticed, the concerned bidder (s) will not be allowed to participate in the auction.
13. Only one person will be allowed to enter the campus with person going to take part with auction.
14. The successful purchaser will be given delivery of auctioned stores after depositing sale Tax with Sale Tax office.


