
**Memorandum**

Notification

G.S.R. \_\_\_\_\_.- In exercise of the powers conferred by sub-section (1) read with clauses (a) and (c) of sub-section (2) of section 155 of the Sashastra Seema Bal Act, 2007 (53 of 2007), the Central Government hereby makes the following rules to amend the Sashastra Seema Bal Combatised, Sub Inspector (General Duty) Group 'B' Non-Gazetted post Recruitment Rules, 2013, namely: -

1. (1) These rules may be called the Sashastra Seema Bal Combatised, Sub Inspector (General Duty) Group 'B' Non-Gazetted post Recruitment (Amendment) Rules, 2019.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Schedule to the post of Sub Inspector (General Duty),-

(A) in column (7), under heading "The relaxation will be permissible in height and chest to the candidates as follows:-" the following shall be inserted at the end of sub-heading "Height", namely:-

"The minimum height both for Male Gorkhas and Male Scheduled Tribes of North Eastern States will be 157 cms."

(B) in the entries under column (12), for the heading "Departmental Promotional Committee consisting of:-" the heading "Departmental Promotion Committee (for considering Promotion) and Departmental Confirmation Committee (for considering Confirmation) consisting of:-" shall be substituted.

(C) under column (10) and column (11), the word "absorption" shall be omitted.
